Actuarial analysis of health costs through the **Electronic Health Record**.

Objective of the activity:

Reflect on the importance of data collection for actuarial and financial valuations in Social Security systems and to discuss whether Electronic Files are useful tools for the actuarial community.



Background:

The good practices resulting from the implementation of Digital Health Records; for example, the EDUS in Costa Rica, or eHealth systems in some other countries of the region, have motivated the American Commission on Actuarial Sciences and Finance (CAAF) to examine that the statistical information collected, serves the interests of actuarial research, that is why it is proposed to encourage dialogue on this topic. While it is true that the actuary's task is to evaluate the economic, social, demographic and financial parameters in order to submit them to analysis and make projections of the

financial solvency of Social Security systems, this diversity of platforms that organize information is currently beneficial in all fields of knowledge for Social Security. It is a matter of opening the reflection on the usefulness in this area. It is also part of the quest to continue broadening the knowledge of actuarial studies. 
