Background

This year we celebrate the 80th anniversary of the Inter-American Conference on Social Security and, concurrently, the 61st anniversary of the first meeting of the American Commission on Occupational Safety and Health (CAPRT). This period is also characterized by important efforts in favor of the worker protection and prevention of occupational hazards undertaken by authorities and
