Justiciability of Social Security









Programme description

The origin of the Social State of Law entails the study and analysis of the international legal system related to the current legal aspects of social security, which is the pillar of justice in today's world. "There will be no social justice without social security" (Diaz Limon, Jose. "La seguridad social, un enfoque histórico".) [Social Security: historical approach].

The development of social security has recognized two phenomena. On the one hand, there has been a considerable progress in social assistance. On the other, there is an approach on health care and livelihood protection, such as pensions. standards by the Supreme Courts. For instance, the human rights reform of mid-2011 in Mexico or Ruling T-561, 1992

of the Constitutional Court of Colombia fall into this category. To this effect, social security is a basic human and social right that is in charge of the State, for its legal fulfilment.

This is a reflection of the international trend, mainly in Latin American, where it is evident that the fundamental social security right is not necessarily guaranteed by secondary laws nor recognized by the Supreme Courts.

The new Latin American social constitutionalism supports the right to social security through jurisdictional mechanisms and the application of constitutional

In this context, the analysis and debate on the justiciability play a major role to guarantee the right to social security, in relation to the actions, mechanisms and procedures that allow its full enjoyment

Cum Laude in labour law and social security from the CEU San Pablo University, in Madrid.

Tenured professor and researcher at the UdG. Coordinator of the PhD programme in research law at the same university. Postgraduate professor at different Latin American universities. Chief guest researcher and lecturer at the Max-Planck Institute for Social and International Law, based in Munich. Member of multiple international academic associations and the Editorial Board of specialized legal journals.

Former Coordinator of the PhD programme in research law at the UDG; Director of the Division of Social and Human Sciences, and Head of the Department of Legal Sciences of the Tonala University Center. He worked as Chairman of the International Board of Directors of the Ibero-Amercian Association of Labour Law and Social Security; and Executive president of the organizing committees of the First World Congress for Labour and Social Security Law.

He was appointed "Emeritus Master" in UdG. Received the "National Award for Legal Research" for the "Antonio Gomez Robledo" legal award as Researcher of the Year. The "Guillermo Cabanellas" medal in Puerto Rico and the "Venera Guillermo Hori Robaina" of the Mexican Academy of Labour Law and Social Welfare, among other awards.

Author or co-author of sixty-three law books, fifteen of them specialized in labour and social security. In addition, he has published more than a hundred of legal articles that have been translated into different languages.
